The named Beagle is "Listed" with the Canadian Kennel Club and eligible for individual registration. A certificate of individual registration will follow no later than 6 months from the date of sale, pursuant to the Animal Pedigree Act.

The Beagle is being sold on a NON BREEDING agreement. The Beagle will not be bred to produce offspring that will be distributed to any dog broker, laboratory, pet store, etc.

Upon receipt of proof of sterilization, the Breeder agrees to refund \$50.00.

The Beagle has been bred with knowledge of ancestry and all reasonable care has been taken to avoid producing genetic defects.

The Beagle has been examined by a licensed veterinarian and received all required vaccinations to date. A record of health is enclosed.

The Beagle has been appropriately medicated for internal parasites on the following dates,

The Purchaser agrees to keep the Beagle in good health by following the vaccination schedule. The Beagle is due for vaccination on \_\_\_\_\_.

Failure to follow the vaccination schedule will void the health guarantee.

The Purchaser agrees to have the Beagle examined by a veterinarian of their choice in the first week of bringing the beagle home. Should the Beagle to be found to be unhealthy in any way, the purchaser may return the Beagle for a full refund. The Breeder requires a letter on veterinary letterhead explaining why the Beagle is unhealthy.

Any costs incurred in returning the Beagle will be the responsibility of the Purchaser.

Should the Beagle be found to be unhealthy and the Purchaser refuse to return, the health guarantee will be void.

The breeder guarantees the genetic health of the Beagle for 2 years (until the Beagle's 2nd birthday) The health guarantee is intended to cover any ailment which would affect the Beagle's "quality of life". It is not intended to cover such ailments as Cherry Eye, Overshot or undershot bites (including Parrot mouth) undescended testicles or any ailment that accompanies geriatrics.

The Breeder agrees to guarantee the Beagle's neurological health for 4 years.

Should the Beagle be presented with a genetic disorder,

- The Purchaser will provide a letter on veterinary letterhead describing the condition of the animal,
- The Purchaser will allow the Breeder to contact the diagnosing veterinarian directly,
- The Purchaser will allow the diagnosing vet to discuss the condition directly with the Breeder's veterinarian,
- The Purchaser agrees that the Breeder may take the Beagle to her own veterinarian for a second opinion (at the Breeder's discretion)

**THE BREEDER WILL NOT PROCEED WITHOUT BEING ALLOWED ACCESS TO THE DIAGNOSING VETERINARIAN**

The Breeder WILL refund 50% of the Veterinary expenses involved in diagnosis up to but not exceeding the purchase price of the Beagle.

The Purchaser will keep their Beagle!

Any medications will be the responsibility of the Purchaser.

Should the beagle become unsuitable for any reason, it will be returned to the breeder. Financial reimbursement to the previous owner will be based on the physical and mental condition of the beagle at time of return. There will be no reimbursement until the Beagle has been rehomed. Any expenses incurred in the return of the beagle will be the responsibility of the purchaser.

Should the Breeder be made aware that the Beagle has been abused or neglected in any way NO FINANCIAL REIMBURSEMENT will be made. The Breeder reserves the right to seize the Beagle from an abusive home and will proceed with criminal charges. In addition to charges laid by the authorities, the Breeder will levy a \$2000.00 fine per infraction. The Purchaser shall be responsible for any and all cost incurred by the Breeder.

The Purchaser will provide details to the Breeder should the Beagle be rehomed by means of willed to a family member or friend.
